
## Installation

## **Hardware Installation**

- Connect a CAT5/6a Cable to the RJ45 Port on the Network Adapter and to a Network Device.
- 2. Connect the **USB-C Connector** on the **Network Adapter** to a USB-C port on the **Host Computer**.

### **Driver Installation**

- 1. If the **Drivers** do not automatically download when you connect the **Network Adapter** to the **Host Computer**, a message that a **Virtual CD** is loaded will appear.
- 2. Click on the message, the **CD Drive** screen will open.

Click on the folder that is compatible with your Host Computer and run the RTK\_ NIC\_DRIVER\_INSTALLER file to begin the background installation.
